## CHANGES IN FOREIGN MINISTRY

Circumstances in the Foreign Work have necessitated certain changes in the Foreign Ministry, to take effect immediately.

I am sending Mr. Robert Fahey, formerly manager over the churches and Work in South Africa, to take charge of the Work in Australia. I am cancelling all services in all churches in Australia for this Sabbath, July 19, as a day of fasting and prayer for peace and harmony in God's Church over the Australian continent, and on the following Sabbath, July 26, combined services will be held in all cities where there is more than one local congregation.

Mr. Gerald Waterhouse also is going immediately to Australia, to preach to these combined church congregations in Australia. He has just completed his tour speaking to churches throughout Canada, and will now travel over Australia. Before Canada, Mr. Waterhouse spoke to every local church in the United States, touring at the rate of some six or seven churches every week.

Mr. Dibar Apartian had been removed as Director of the French Work, and apparently for the sole reason that he was loyal to Christ's Apostle and to Jesus Christ. I reinstated him, and now he is reinstated also over the French-speaking churches in eastern Canada as he was before.

I am sending Mr. Larry Salyer, who has been pastor of the AM church at Pasadena headquarters, as assistant to Mr. McCullough, second in charge over all churches in Canada (except French-speaking).

There has been no office as Director of Foreign Work since I abolished the office of Pastoral Administration, although I have approved two or three visits to overseas offices by Mr. Leslie McCullough. Supervision over all foreign work continues to remain in Ministerial Services, under my personal direction.

Mr. Dean Wilson is being transferred to be in charge of the three churches in Portland, Oregon.

The Work of the living GOD continues to be SET BACK ON THE TRACK!

Meanwhile, in Ambassador College, Mr. Rod C. Meredith has returned from his leave of absence and will teach 3rd-year Church of God Doctrines, Epistles of Paul, and introductory Homiletics.

adult baptized members. Yet on national television's No. 1-rated *60 Minutes* Mike Wallace called us a "wealthy Church!" The living GOD has made us a powerful Church. The millions hear His Message through us. And neither you nor any human source can stop that Message nor hurt our STRENGTH!

You see, our STRENGTH does not reside in numerical numbers. Jesus Christ said of us, "I know that you have but little power, and yet you have kept my word and have not denied my name. . . . I have set before you an open door, which no one is able to shut" (Revelation 3:8, Revised Standard translation).

Now what, in retrospect, have you done? True, you caused us irreparable damage through the public press and newscasts, in our public image before many throughout the United States. You have damaged us financially to the extent of a few million dollars—which the living GOD made us adequately able to bear. But our God has used your politically motivated persecution to strengthen His Church—to draw our

devoted members closer to Him and to be more unitedly welded together. You have stimulated the Source of our STRENGTH!

That all-important END-time Gospel Message shall now go forth to the nations of this world in greater POWER than ever! It is the Message from God—the GOOD NEWS of the soon-coming world of PEACE—a world that shall be as filled with the knowledge of the Great GOD as the ocean floors are filled with water! Mr. Attorney General, you underestimated us—or rather you underestimated the GOD we serve and whom you ill-advisably attacked! You listened only to a handful of expelled, former members. You accepted their testimony without doing your "homework"—ascertaining the facts as they actually exist. You fell into their trap. In so doing you attacked and persecuted the living GOD and His TRUTH. But HE has turned your persecution into a significant growth in the Church's strength. Newly baptized members now are increasing at the rate of 30 percent per year.

### Visiting Tour of Spain and Portugal

Mr. Fernando Barriga of the Work's Spanish Department here, returned June 3rd from a month-long tour of Spain and Portugal. The tour, which was Mr. Barriga's seventh since 1975, took him to 19 cities in Spain and two in Portugal. He visited 21 members, 32 prospective members, and conducted five group Bible studies. There was one baptism, but since one member had recently died, our membership total remains at 17 in Spain and five in Portugal.

The purpose of the tour was twofold: 1) to visit and encourage the members and prospective members and to baptize those who were ready; and 2) to look into the possibility of keeping the Feast of Tabernacles in Spain for the first time in the modern era of God's Church.

Mr. Barriga was only able to baptize one prospective member, Mrs. Nelly D'Arumont Van Geffelen, on this trip. "The principle obstacles preventing many of the others from taking the plunge," explained Mr. Barriga, "are the Sabbath and tithing." Mrs. Van Geffelen, who is Belgian, and her husband (who is not yet a member) formerly lived in Zaire (Belgian Congo), where they first came into contact with the Work's publications (in French.)

"Mrs. Van Geffelen and all the other members were excited to learn of the possibility of keeping the Feast in Spain," said Mr. Barriga. "They wish they could get together every Sabbath, but unfortunately they live too far away from each other," he further explained.

Now that plans have been approved, the Feast will be a unique opportunity to fellowship not only with their brethren from the Iberian peninsula, but also with brethren from overseas who will be attending. The Feast will be held at a first-class, four-star 117-room hotel with a private beach just south of the city of Valencia on Spain's southeast coast.

"Overall," Mr. Barriga concluded, "the whole tour was very positive. All of the members I visited were encouraged and moved at least a few steps forward. They pray for the Work and for Mr. Armstrong, and they ask their brethren around the world to pray for them."

### Comments From Monthly Church Reports

ELKHART, IN--RAND MILLICH: The Church reacted very positively toward Mr. Armstrong's comments concerning how close we are to the tribulation and to the return of Jesus Christ. The vast majority are strongly backing the Work of God and realize how much this world needs God's intervention.

CINCINNATI EAST, OH--R. SHORTY FUESSEL: Things are going very well in the area. No unusual problems or bad attitudes. Just the regular human problems. Everyone enjoyed the Putnam interview. #### ON THE WORLD SCENE

WHITE HOUSE CONFERENCE ABETS FAMILY DOWNFALL: By the time the White House Conference on Families pulled into Los Angeles for its final stop last week, it was already apparent that the effect of the conference would be to further weaken the American family unit.

The two previous meetings of the touring "All in the Families" road show had already endorsed abortion on demand, homosexual rights (in housing especially), and the Equal Rights Amendment. Other resolutions seem to have been taken right out of Ted Kennedy's campaign platform, namely national health insurance and a guaranteed annual income of \$13,000 a year for a family of four. The Washington Post called the resolutions a "laundry list of liberalism."

The White House Conference was created to fulfill a campaign promise Jimmy Carter made to evangelicals to help the family as an institution. However, in practice, the conference was taken over mostly by radical activists--feminists, social workers, homosexuals, and liberal clergymen--who were more concerned with pushing big government spending programs and weakening the traditional family structure rather than helping it. Thus, early on, the name was changed from "White House Conference on The Family" to the "White House Conference on Families," the Administration yielding to pressure from the activists who wanted endorsement for their perverse concepts of what constituted a family (such as a lesbian mother now living with a lesbian lover, but rearing a child and using the facilities of a federally-funded day-care center.)

Moreover, the delegate selection process was blatantly rigged. The original rules allowed for a majority of the delegates to be popularly elected, with the rest to be appointed by the state governors. But after "pro-family" groups won the elections in one state, the rules were changed to give the governors (who were subject to radical pressure) power to appoint most of the delegates. Overall, governors ended up appointing more than 80% of the conference delegates.

One interesting incident shows the anti-family attitude of those who ran the conference. At the Baltimore meeting, personally opened by President Carter, one of those in attendance was Dr. Joel Rosenshein, an

Orthodox Jew. The resolution endorsing homosexual rights, abortion on demand, the ERA and three minor issues was scheduled to be brought to a vote on Saturday, June 7. Dr. Rosenshein asked several times for an absentee ballot, since he wasn't going to attend any sessions of the conference on the Sabbath. His requests went unanswered. As it turned out, the resolution passed by only one vote: 292-291. Dr. Rosenshein would have voted against it, creating a tie and preventing its passage. (A walkout of a group of 55 conservative anti-abortionists and anti-gays also paved the way for the resolution's passage.)

The victory surprised Joan Deforeest, a lesbian delegate from Reading, PA. "I expected to make a statement," she told of her decision to attend. "I thought it'd be a gesture representing millions of gay families around the nation. I didn't expect to ever get farther than that."

One delegate, avowed homosexual and "gay rights" activist, Eric Rofes, was ecstatic that "his side" had won.

"The White House Conference today voted to support gay rights," Rofes said incredulously. "That's historic. It has to be noted because 10 years ago we wouldn't have been allowed to come in here." Even by one vote, that has to impress me. It shows there is a strong enough group here that feels enough about the civil rights of lesbians and gay men to stick their necks out."

God says, of course, that such a "victory" will be short-lived: "The show of their countenance doth witness against them; and they declare their sin as Sodom, they hide it not. Woe unto their soul! For they have rewarded evil unto themselves" (Isa. 3:9).

In Los Angeles, incidentally, the conferences endorsed roughly the same bag of proposals--ERA, abortion on demand and homosexual rights in housing. As a result, one group in attendance, the National Pro Life Coalition, termed the White House Conference "a fraud." Connie Marshner of Washington, D.C., coalition chairman, objected to the conference "legitimizing" non-conventional families such as gay and unmarried heterosexual households.

"A government, which, regardless of the benevolence of its intentions, attempts to take over the family's job of providing for the needs of its members, is laying the groundwork for the destruction of the family unit," the group stated in its position paper.

### Castro Uses U.S. as Gay Dump Site

Perhaps Fidel Castro was watching the antics of the farcical White House Conference too. Of the 115,000 Cuban refugees he has let go recently, as many as 20,000 of them, reports the Washington Post, are said to be homosexuals! To engage in homosexual acts is a crime in Cuba, so Fidel knew where to dump his unwanted "gays"--into the "Land of the Free" (to do every licentious thing.)

"The Immigration and Naturalization Service no longer keeps people out just because they are homosexual," Mr. Robert Havel, a spokesman for the U.S. Justice Department, told the Post. "There was a time when they were kept out because homosexuality was considered an illness. But the United States Public Health Service no longer sees homosexuality that way."
