CONGRESS OF LEADING MINISTERS HEARS DEFINED AND REEMPHASIZED SPIRITUAL ORGANIZATION OF CHURCH

STANLEY R. RADER RESIGNS EXECU-TIVE RESPONSIBILITIES--CONTINUES A.I.C.F., LEGAL AND FINANCIAL ADVISOR TO HERBERT W. ARMSTRONG

Stanley R. Rader has decided to resign from his executive responsibilities as Treasurer and Board Member, effective March 1. He had decided to make this resignation effective early in January, 1979. But the sudden invasion of the Attorney General's Office lawsuit on January 3, 1979, made it necessary for him to stay on and direct our legal defense until the lawsuit was dropped.

On Wednesday, February 25, a congress of leading ministers and office managers from all points around the world heard the Pastor General, Mr. Herbert W. Armstrong, define and reemphasize the spiritual organization of the Church, and update them on the plunge forward now under way as we enter the homestretch of the Work of the Living God.

The following was the crux of Mr. Armstrong's address to the congress of ministers.

Message to Congress of Leading Ministers from all parts of the world, at Pasadena, February 25, 1981.

TO THE CONGRESS OF LEADING MINISTERS FROM ALL PARTS OF THE WORLD, ASSEMBLED AT PASADENA.

#### **GREETINGS:**

I have called this Congress of Leading Ministers of God's Church world wide because:

- 1) Conditions in the world fulfilling Biblical prophecies are now fast accelerating, indicating we are, indeed, in the very last days of this present evil world, and
- 2) This has necessitated a dynamic stepping up in the intensity of God's Work by His Church proclaiming Christ's Gospel of the soon-coming KINGDOM OF GOD, and to acquaint you with the plans for this intensified

homestretch finishing of the Great Commission the living Jesus Christ has called us to do, and

3) to UPDATE you, so that you may update the brethren under you in the true PURPOSE, the organization and government of the Church of GOD for this time and this paramount Commission.

Former Prime Minister Winston Churchill, speaking before a joint session of the United States Congress at the time of World War II said, "There is a PURPOSE being worked out here below." A Higher Power above is working out His PURPOSE! That purpose is the creation of perfect, holy and righteous CHARACTER in separately-created beings for continuing God's creative Work throughout the endless UNIVERSE perpetually, time without end.

First, while God can create separate living entities, this righteous spiritual CHARACTER cannot be created automatically by fiat. The individual created being must make his own decision and take his own action in the CHARACTER-creation.

God first created angels. He placed angels on this earth at it's creation. God set a throne of earthwide rulership on the earth. He placed on that throne a super archangel, the great cherub Lucifer, to administer the GOVERNMENT OF GOD over the earth and those inhabiting it.

Lucifer rebelled and led his angels into rebellion. He became Satan the Devil. His angels became demons. They are SPIRIT beings with immortal life. Satan is still on that throne, invisible to human eyes, TODAY!

So God created MAN in GOD'S image, but composed of MATERIAL flesh and blood from the GROUND. The first man, Adam, made the decision for his HUMAN FAMILY--the WORLD--to reject the GOVERNMENT OF GOD, based on the LAW of God. His sin cut THE WORLD as a whole--all but the minute FEW God would specially call--off from God and His immortal-life-impregnating HOLY SPIRIT, UNTIL the restoration of the GOVERNMENT OF GOD over the earth. They are reserved for their JUDGMENT DAY after restoration of GOD'S GOVERNMENT over the earth--in a resurrection to judgment in an afterlife, as explained in Revelation 20, Ezekiel 37 and other Scriptures.

Jesus Christ, the second Adam, came more than 1950 years ago. He QUALIFIED to restore the GOVERNMENT OF GOD, and to establish on earth the KINGDOM OF GOD. He said, "I will build my Church and the gates of the grave shall not prevail against it."

The Church of God which He founded in A.D. 31, is a SPIRITUAL ORGANISM --not a secular human organization. But it is ORGANIZED on God's spiritual pattern as explained in I Corinthians 12, Ephesians 4 and other New Testament Scriptures. Of course GOD the Father is HEAD over ALL. Jesus Christ is living Head of the Church. Under Him apostles were given oversight of the Church and its organized Work. Though a spiritual organism, it is organized, not on a carnal human pattern, but on God's spiritual pattern.

The Gospel of Jesus Christ is the MESSAGE HE PROCLAIMED! That Message was the Gospel of the KINGDOM OF GOD--the restoration of the GOVERNMENT of God by the coming KINGDOM of God.

The Apostolic Church from 31 A.D. proclaimed that Message, but with special emphasis on the resurrection of Jesus Christ, of which they were eyewitnesses. The population of the whole world then was probably no larger than one of the states of the U.S.A. There were no mechanical and technological facilities such as we have today, in areas of COMMUNICATION and TRANSPORTATION.

The two SPIRITUAL AREAS of the PURPOSE of the Church are, 1) proclaiming the Good News of the KINGDOM OF GOD for a witness to the nations of the world (Matthew 24:14), and 2) to "feed the flock"--on the spiritual food of the Word of God. That's ALL they had in that day. But today we carry on God's Work in a world multiplied larger in population--a mechanized, mechanical world with instrumentalities to work with, never dreamed of in the first century.

The basic organizational pattern is the SAME--but today we must utilize SUPPORTING SERVICES in scientific, technological and mechanical areas that were nonexistent in the first century. Moreover we have to deal with the world's governments in a manner quite different.

Therefore I show you an overview CHART of the Church's Organization and Government to carry on the Work of God by His Church in this 20th Century (Matt. 24:14; Mal. 3:1-5 & 4; Hag. 2).

Now we are already into a stepped-up homestretch spurt of this END-TIME Work God has given us to do. I am already deep into a new series of television and radio programs. I have twelve of the new programs already recorded in advance, beside those already aired.

Of course the major city newspaper full-page messages have been under way, and especially in the Wall Street Journal. In that paper we reach just about everybody who OWNS or wants to own the properties, and especially corporate properties of the U.S., and everybody who runs, or wants to run, the governments of the United States. We plan to greatly expand this means of sending out Christ's Message. Just day before yesterday the number one TV station of Chicago, WGN, opened to us. That is the most powerful outlet for reaching that populous midwest area since the radio program on WLS many years ago which built the Church membership in that region.

We have plans for stepping up the newsstand circulation of The PLAIN TRUTH. We plan to resume purchasing large space for Christ's Message in such publications as Reader's Digest and TV Guide, which have MASSIVE circulations reaching many MILLIONS. For all of this I am having to ask our members and co-workers to make extra sacrifices and increase their freewill offerings. We DO NOT, and WILL NOT solicit the public for contributions. But God does expect His people to make sacrifices for Him, especially at critical times.

I shall need the support of our Ministry in this, so that the additional expansions may be financed. All this additional pressure we are putting on in taking Christ's Message more powerfully now to a multiplied listening, viewing and reading public will, in a few months, begin to bring in additional NEW VOLUNTARY co-workers. The additional money we must put into this expanded program now is like pump-priming--where we used to put an amount of water into the pump to prime it, and then it produced a flow of water multiple times larger than the original priming.

Now I come to another matter.

Just over two years ago, on January 3, 1979, armed deputies under the California Attorney General's office suddenly, without notice, invaded the Pasadena headquarters of God's Church and College. It was a massive lawsuit attack that threatened to DESTROY God's Church and His Work.

It was primarily through the extraordinary work of Mr. Stanley R. Rader that the Church, its activities, facilities for those activities, properties and assets were protected, preserved, kept in continuous operation, and their destruction prevented. These properties and facilities, which I would conservatively value at more than \$100,000,000, were saved for the Church.

- 1) Mr. Rader had the expertise (prior to this) to guide the installation of what I feel undoubtedly is the most sophisticated accounting system of any church in the United States prior, of course, to this massive government, unconstitutional invasion. During our legal defense, which he masterminded, he had the wisdom to hire the largest C.P.A. firm in the United States, Arthur Andersen & Company, to audit all our records, and to relate to this very prestigious accounting firm so as to clear the Church and its officers of any allegations of financial wrongdoing. This was a mastermind strategical move. The Attorney General's case was doomed from the time of the Arthur Andersen & Company audit.
- 2) Mr. Rader masterminded the bringing together in our defense highly qualified attorneys from at least seven top legal firms to defend the Church in the many hearings and court appearances. Mr. Rader had the ability to command the respect of these prestigious legal firms, and to assume overall legal leadership as a Master General of a Master Legal Army to defend us against the overwhelming legal army of the State.
- 3) Mr. Rader spent much time in Sacramento working behind the scenes with other organizations that were working to put the Petris Bill through the Legislature. This Bill nullified the law on which the Attorney General's office based their case against the Church.
- 4) For the two years Mr. Rader was working effectively with the media nationally--Television, radio, and the press--using expertise in the media field over and beyond ordinary lawyer services. He appeared on talk shows over the nation, on many interviews, press conferences, turning public opinion in the Church's favor.
- 5) He utilized authorship in writing articles, and his book Against The Gates of Hell, communicating the Church side of the lawsuit before the world.
- 6) He had the extraordinary ability to coordinate all of this and put it together in an effective and winning spearhead.

These activities extended in extraordinary manner completely beyond the abilities and services and efforts of even the best and most famous of attorneys. Yet normal attorney's fees, totally incomparable to these extraordinary and effective activities, would run into many hundreds of thousands of dollars. Corporations have to pay very highly for ordinary legal services in corporate lawsuits. Ordinary legal services, even from

top lawyers of national reputation, in my judgment, could not have won this battle and kept God's Church alive and active. I feel that Mr. Rader's salary is grossly inadequate for these extraordinary services.

Mr. Rader had expressed a desire to retire from official Church executive position prior to the January 3, 1979 state invasion. He and I had agreed to his retirement from this executive position very shortly before January 3, 1979, to take effect very soon after the beginning of the year of 1979. When the State attack was launched January 3, it became necessary for him to stay on.

For many years now Mr. Rader has rendered extremely valuable services to this Church in the fields of Law, Accounting and Finance, besides invaluable services as my assistant in carrying Christ's Gospel Message to and through Kings, Emperors, Presidents, Prime Ministers, and other leaders of nations over all the continents of the world. He has the expertise in the field of government to complement me in talking to as many as SEVENTY heads of governments, or near heads. I feel sure no man has talked in private conversation with as many such government heads, in their own capitals over the world, as have Mr. Rader and I.

I feel this Church would be derelict in its appreciation if it does not make suitable acknowledgment for such service, rendered two years after Mr. Rader had planned to retire from active executive duty.

For the past five months or so he has said publicly in the public press, and before our own congregations, that it is his desire to return to private law practice, and has made public statements of intent to resign as Treasurer and Board member of the Church by July 1. Now he has asked that this date be moved up to March 1.

To show our appreciation, it is my judgment as Pastor General of this Church, that we should express our gratitude and heartfelt appreciation by a special bonus of \$250,000, net to him.


I would at this time like a voice approval from you who are leaders in the Ministry of this Church.

Mr. Rader will continue on as Executive Vice President of the A.I.C.F., the performing artist series in the Ambassador Auditorium, and in time and spacebuying for T.V., radio, and publication space, and as my chief advisor in legal and financial areas and in such Gospel trips abroad as I shall take, but resigning his executive responsibilities in the office of Treasurer.


Mr. Leroy Neff, Evangelist in God's Church, has been appointed as Acting Treasurer.

#### Mr. Herbert Armstrong Speaks in Seattle

(The following report on Mr. Armstrong's recent trip to Seattle comes from Mr. Dennis Luker, Pastor of the Seattle Church.)

On the Sabbath of February 14, Mr. Herbert Armstrong spoke in Seattle, Washington to an overflow crowd of 2,713 brethren. This included members from all churches in the state of Washington plus a number from Portland, Oregon and Vancouver, B.C., Canada.

Mr. Armstrong was accompanied by his wife, Ramona, and by Mr. and Mrs. Dean Blackwell and Mr. and Mrs. Leroy Neff. Mr. Blackwell and Mr. Neff are evangelists in God's Church.

The brethren were very excited because Mr. Armstrong had not visited this area and spoken to the churches for about twenty years. A large number were seeing and hearing him in person for the first time. They were not disappointed. Mr. Armstrong spoke for over two hours and was very strong both in delivery and in what he said.

His sermon subject was "What and Why Is the Church?" Mr. Armstrong made it very clear that this is the Church of God, not the church of a man. But he did explain how God called him, trained him and has used him to build this Work. He reminded us of where we learned the truth and strongly exhorted and encouraged us to remain loyal and faithful through the trials that lie ahead.

Mr. Armstrong's presence and manner of speaking was very encouraging and strengthening to all of us. He spoke with power and authority--beyond the human strength of a man nearly 90 years old. He told us all that he loved us and thanked everyone for being patient while he spoke for over two hours. It was a great blessing and honor to have God's Apostle visit us. We pray he will be able to visit other areas and deliver a similar message.

#### International News

<u>Developments in Australia</u> January 1981 was a most encouraging and profitable month for activities in God's Work in Australia. The new year got under way with an enthusiastic start!

The media and advertising efforts continue to be concentrated on actively promoting a Newsstand Programme, The WORLD TOMORROW on radio and television, and placing Mr. Armstrong's Wall Street Journal ads in major Australian newspapers. Thanks to Jesus Christ who opens the doors for His Work, some major breakthroughs have already been achieved!

The Newsstand Programme is already under way with an initial 15,000 copies of the newsstand edition of The PLAIN TRUTH magazine being distributed in January, rising to 25,000 in February. Newsstands already approved are: three at Sydney Railway Stations; two excellent outlets at the Sydney International and TAA Domestic Air Terminals; three downtown stands in Melbourne; one stand on the main railway station in Adelaide; three outlets in downtown Hobart; and three in the city of Perth, one of

# The Executive with Rose-Colored Glasses

# He was a bit ahead of his time. Still, things will be far more rosy than he sees them now!

T's a PLEASING deception, perhaps, to see the most terrible and widespread evils of human history as if they were nonexistent, and all is well with the world.

The rose-colored glasses were worn by a highly placed executive of a multinational corporation, on a business trip in Cairo. He had read these page messages in a leading U.S. newspaper, and was one of the guests attending a large banquet in the ballroom of the Nile Hilton Hotel. I was the principal speaker, and I was speaking on the current troubled world condition—its causes, and what lies ahead.

To one beside him he commented that he respected what I am doing, but disagreed that world conditions are really bad. He has it made, economically He lives well, enjoys the very best in material goods. The fact that half or more of the world is suffering, illiterate. living in abject poverty, filth and squalor-many dying of literal starvation-isn't affecting his well-being. The moral downdrift of our youths, the breakdown of the family structure, the escalating crime wave, the continual overthrow of the governments of nations, the wars and threats of wars the myriad knotty, complicated problems and troubles seemingly beyond human solution apparently had not touched or harmed him personally. The anguish of the multiplied millions had not, apparently, as yet reached through to him. But it will!

How many are in the same boat, happily oblivious to others who are sinking? Soon we shall all sink, unless the present world trend is reversed.

When world evils are what they are, and fast accelerating, with the number of nations in the nuclear club increasing, a madman at the helm of any one of those nations could ignite the nuclear explosion that can exterminate us all! Do we have faith in such a madman that he will hesitate to exercise such awesome power?

We are confronted with an almost unbelievable paradox! In the United States and developed nations, progress in civilization has been phenomenal in the 20th century. But this advancement has been altogether in the materialistic and physical realm

Conversely the world has retrogressed and is cursed with more unsolved and humanly insolvable problems and evils than any time since mankind has inhabited the earth. And our No. 1 problem today is that of HUMAN SURVIVAL!

What successes we enjoy are in the materialistic realm. But materialism, no matter how abundant, does not produce happiness, peace, joy, the truly meaningful life. And it leaves us questioning about, in ignorance of, worried about or trying to ignore the question of life after life. Material abundance alone can never satisfy.

Meanwhile the developing countries and the "have-not" countries are lagging or utterly lacking in even material needs, let alone abundance.

Our real problems and evils are spiritual in nature. They are caused by the way of life I call "GET" for simplicity. The way of self-centeredness, vanity, covetousness, envy, jealousy, selfish competition, strife and violence.

This way of life transgresses the overriding spiritual LAW [term "GIVE"—outflowing LOVE toward others, concern for their welfare, serving, cooperating, sharing. That invisible spiritual law is as inexorable—as relentless in automatic motion as the law of gravity!

We can never have a happy, meaningful, satisfying life and world UNTIL WE
REPEXT—TIEN FROM—THE SELFISH WAY

will not!—the unseen "Strong Hand
from Someplace" will soon intervene in

destroying itself and rule all peoples of
the earth with the Law of "GIVE" instead
of "GET." This will usher in the happy,
peaceful, abundant world tomorrow.

these being strategically placed in the main Perth bus depot. Other newsstand outlets are under consideration.

Soon The WORLD TOMORROW radio broadcast will be once again heard on the air waves in Australia. Already three stations in Western Australia-- 6KG Kalgoorlie; 6GE Geraldton; and 6BY Bridgetown/Katanning--have accepted the programme and broadcasting is scheduled to begin March 1st.

Progress has also been made to begin airing the "World Tomorrow" television programme. At present options with two stations in Adelaide, two in Perth, and one in Brisbane are under consideration and negotiation. Within the next couple of weeks it is hoped to secure television coverage in Sydney and Melbourne.

A really exciting breakthrough is the successful placing of Mr. Armstrong's Wall Street Journal Ads in four leading Australian newspapers. As these comments are being prepared, the first of Mr. Armstrong's ads appeared February 2nd in the Sydney Morning Herald (circulation 258,000), the Melbourne Age (circulation 244,000), the Brisbane Courier Mail (circulation 270,000), and the Adelaide Advertiser (circulation 228,000)—total circulation of 1,000,000 copies!

"A Voice Cries Out," in bold black headlines one and a half inches high, dominates the full-page advertisements. The ads will appear twice a month in the Sydney Morning Herald and the Melbourne Age, and once per month in the Brisbane Courier Mail and the Adelaide Advertiser.

Canadian Summary The first month of 1981 is now history! The office staff hardly had an opportunity to catch their breath after a record-setting December, and year 1980. Now they find themselves well into a new year, and nothing seems to be "letting up."

The mail continues to come in very heavy, due to a massive renewal of those many thousands of names added to the file last spring as a result of the newspaper insert programme all across Canada.

Even though income has trailed off somewhat (11% over last January), the prospect for 1981 remains very good indeed. The expanded newspaper coverage with Mr. Armstrong's full-page ads is creating a public awareness in circles where the Church has gone virtually unnoticed to date.

News From New Zealand For the third year in a row, God has blessed us with an excellent January income increase, with this January topping the figure for the same month last year by 32%.

During the month of January, Mr. David Hulme of the Vancouver office, who has been in Australia working on media plans for God's Work there, visited Auckland for a few days to help with our media arrangements for the coming year. Our main goals are to place Mr. Armstrong's series of full-page ads into leading newspapers here, to put The WORLD TOMORROW broadcast back on radio, to establish a newsstand programme and to keep PLAIN TRUTH circulation up.

Mr. Hulme arranged for an appointment with Whitaker Advertising--part of New Zealand's number one advertising group--which is affiliated with the advertising agencies used by God's Work in Canada and Australia. The Agency staff were very excited about the material we were able to show

them, including a telecast of Mr. Armstrong, part of the "Young Ambassadors" film, the Envoy, AGAINST THE GATES OF HELL, and some copies of The PLAIN TRUTH and QUEST/81. Finally, we were able to show them Mr. Armstrong's advertisements. They couldn't believe their eyes, commenting that they had never seen such clean and well laid out copy.

Already we are lining up a series of ten of Mr. Armstrong's full-page ads to run in the New Zealand Herald and the Dominion, the morning newspapers in the nation's two largest cities. These ads are to begin appearing in March. Full-colour newspaper inserts advertising The PLAIN TRUTH will also be run in some of the nation's leading newspapers in May and October. We estimate that these promotional activities should add at least 20,000 new PLAIN TRUTH subscribers during the coming year.

<u>CHURCH WINS FIRST VICTORY</u>
<u>IN CALIFORNIA COURT SYSTEM!</u>

February 26, 1981

On October 15, 1980, the attorney general dismissed his complaint against the Worldwide Church of God and all other parties named in the lawsuit.

At that time, an appeal was pending in the District Court of Appeals. It was this appeal that resulted in the several million dollars of individual surety obligations being undertaken in the Spring of 1979 by the devoted brethren of the Church in order to stay [put on hold] the receivership until the appeal would be decided.

Immediately upon the Superior Court's entering of the dismissal of the lawsuit as requested by the attorney general, the District Court of Appeals was also petitioned by the Attorney General to dismiss the Church's pending appeal as moot. [The A.G. said the matter would be "moot" or no longer a viable issue.]

The District Court of Appeals, unfortunately, when it issued its order did not clearly state that the matter before it is moot. This gave significant encouragement to the adversaries of God's Church, including the receiver and Mr. Chodos, because the District Court of Appeal's failure to declare the appeal moot suggested that the Superior Court still had some kind of continuing jurisdiction.

In fact, Chodos immediately filed an appeal himself to the same District Court of Appeals contending that the attorney general had improperly dismissed his complaint and arguing that the receivership should be immediately reinstalled.

We took these matters to the California Supreme Court and yesterday, in a very unusual manner, the Supreme Court granted the hearing and at the

same time ruled unanimously in favor of our petition! Thus the High Court bypassed the District Court of Appeals and declared the matter moot.

This decision, so unique in California Appellate Court procedure, should have significant bearing on the remaining matters still pending in the state court system.

We still have pending our appeals of the lower court's awarding of fees to the receiver and we are still attempting to get the California District Court of Appeals or the Supreme Court to rule that the initial imposition of the receiver was unlawful from the outset.

It is interesting that the highest court of the State of California, in its first appellate ruling has granted us the <u>exact relief</u> that was requested.

#### FROM Y.O.U.

#### S.E.P. Update

Plans are well under way for S.E.P. at Orr this summer. As was announced earlier, we will be running three 3-week sessions with tuition staying at \$175 plus a \$25 clothing fee.

Dates for each session are: Session I June 10-June 29
Session II July 3-July 23
Session III July 17-August 16.

To date we have received 675 applications and they are coming in at a rate of 25 per day. We already have enough applications for the second session to be more than full. (No one has been accepted yet, though, as we want to give first-time campers priority.)

If you have young people in your church who want to attend, we encourage you to have them submit their applications as soon as possible and to apply for first or third sessions whenever possible. We will start making acceptances in mid-March.

Along this same line, we just talked with Mr. Tkach about church scholar-ships. He wanted us to encourage any local congregation which can do so to sponsor a deserving youth to camp. This can be done through Spokesman Club sponsorship or in other ways. You can sponsor either a youth from your church or from another church area.

Along another line, plans call for us to do a lot of maintenance and remodeling of the Orr property this summer. We plan to upgrade the dorms, faculty units, and bath houses. It has been several years since any appreciable amount of work has been done on the property in general. This summer's work will help bring the property back up to the standards which Mr. Armstrong desires.

#### Y.E.S. Update

Plans for implementation of the new Y.E.S. program this spring are still on schedule. The first lessons have been approved by Mr. Armstrong and are currently at press. Current scheduled mailing date is the latter part of April. Lessons should be in the hands of each student by early

May. Pastors will receive a packet prior to that time explaining the program in more detail.

#### Y.O.U. Update

Included in this Pastor General's Report is a map showing the new Y.O.U. district and regional boundaries (regional boundaries apply to track and talent only). Also included is a listing of the men who will be serving as District Coordinators for these new districts.

These new boundaries and coordinator responsibilites will become effective with the end of the basketball season and the beginning of the track and field season this year. We again wish to express our deep appreciation to all those who have given of themselves to serve the youth program of the Church in the past. We also look forward to working with all of you men in the future as God continues to lead and direct His Church through Mr. Herbert Armstrong.

The new Pastor's Y.O.U. Manual is now in the final stages of writing. You will each be receiving your copy just as soon as it is approved and printed. Thank you for your patience. Until then, continue to follow the old manual unless a given policy has been superseded by recent material in the Pastor General's Report. If you have any questions, feel free to call Y.O.U. or Ministerial Services.

#### ON THE WORLD SCENE

"TRAVELLING POPE" TOURS ASIA Pope John Paul II has just completed his ninth trip outside Italy in his first 28 months in office. This time the focus was Asia, where his 12-day, 20,500-mile odyssey took him to primarily the Philippines, Guam and Japan with mass-celebrating stopovers en route in Karachi, Pakistan and Anchorage, Alaska.

The biggest welcome of all was in the Philippines, where 40 million of 48 million Filipinos claim church membership. Significantly, the Pope arrived just days after God's Apostle had completed a highly successful series of meetings, forcefully proclaiming everywhere the true Gospel. In the Philippines, the Pontiff ventured into the politics of this world, walking his usual tightrope. He lectured President Marcos--who recently lifted martial law--on the need to preserve "the fundamental dignity of the human person" and the "basic rights" protecting such dignity "even in

exceptional circumstances." Yet, on several occasions, before slum dwellers and agricultural workers, he counselled the poor not to resort to "hate, class struggle or violence" to redress their grievances. He did uphold, however, the sugar workers' rights to organize—a hot political issue—to fight for a "just share" of the industry's profits.

The pope, while hardly shunning political issues himself, counselled the Philippines' political activist priests against meddling in politics as he did on an earlier trip to Mexico. "You are priests...you are not social or political leaders or officials of a temporal power."

While on Mindanao, the pope appealed for peace among the island's battling Christians and Muslims, saying they were "passengers on the same ship." (A common-front approach toward all religions was evident on his stopover in Karachi, Pakistan--an obvious goodwill gesture directed to the world's 800 million Muslims.)

John Paul II also used an occasion in the Philippines to send a radio transmission to all Asia. The message was directed primarily to Communist China, however. He said he "ardently desired to express my affection and esteem to all my brothers and sisters of the Church in China."

Chinese authorities have separated Chinese Catholics from the authority of Rome. The pope wants to restore this link, and desires greatly to go to China. ("He wants to go everywhere," noted a Vatican insider.)

The trip to Japan was the first ever for a reigning pope. (There are only 400,000 Catholics in Japan). In Tokyo, the Pope spoke ecumenically to Shinto and Buddhist leaders, saying that Christians "are willing to collaborate with you on behalf of man's dignity (and) his innate rights."

Visiting the "ground zero" areas of atomic-bomb-devastated Hiroshima and Nagasaki, the pope--embellishing his image as tireless worker for world peace--pledged that "we will work untiringly for disarmament and the banishing of all nuclear weapons. Let us replace violence and hate with confidence and caring."
